The planned EUR 250 million Luxemburg-based fund pursues an integrated investment strategy to provide stable and risk adjusted returns even in times of heightened volatility. Sector-wise, the closed-end fund has a thematic niche approach that enables access to traditional infrastructure assets often overlooked by large-cap players.

# Attractive market opportunity targeting traditional infrastructure assets

Infrastructure remains resilient despite current market volatility and continues to demonstrate strong secular growth. By capturing the combined expertise of real estate and infrastructure, the fund targets investment opportunities in ESG compliant infrastructure driven by, amongst others, the European Union and America's multi-billion infrastructure support initiatives. The fund's strategy aims to benefit from the major shifts in the energy landscape including digitization, and at the same time focus on traditional infrastructure sectors such as social, transportation and communication mainly in areas of fibre roll-out and connectivity, all of which demonstrate need for private investments.

# Integrated investment strategy

The fund's integrated investment strategy offers its investors the full range of private infrastructure investments. By combining primary, secondary and direct investments, the fund aims to build a well-diversified portfolio in a highly efficient manner. Of note, this approach is supported by the dynamic development of the infrastructure secondary market, which will play a key role in the fund's strategy to generate superior value and risk adjusted returns.
